



James River Face Wilderness (JARI1) 2019 Site Report

The Interagency Monitoring of Protected Visual Environments (IMPROVE) is a long-term air pollution measurement program designed to document and track visibility in protected areas. IMPROVE samples and analyzes the haze particles that impair visibility so their sources can be identified and addressed.





In the plots below, mass concentrations measured at James River Face Wilderness give a sense of the seasonal trends of air quality in the area as well as show significant air quality events such as wildfires and dust storms. These are plotted alongside the average measurements across the IMPROVE network as well as its related Chemical Speciation Network (CSN). The CSN sites are located in urban areas where the populations are highest. In general, lower concentrations would suggest better visibility. The lower plot shows annual median concentrations with a gray shaded region to represent the 10th and 90th percentiles.

Long-Term Trends in Reconstructed Fine Mass Missing years are due to low number of RFM values.





The following plots summarize the chemical composition of particles collected at this site. The monthly averaged compositions calculated from 2015-2019 data are shown on the left while compositions for the day with the highest measured concentrations during 2019 are shown on the right.

The following map shows the average RFM concentrations for nearby sites in both CSN and the rural IMPROVE Network. The point shapes indicate which network the sites are associated with. The color bar indicates the average annual RFM concentration (micrograms per cubic meter) measured at each site in 2019.
